#### Cyber Security, Customer Account Documents, ACH Authorization, IB Conference, Presentation Schedule

#### **Cyber Security**

**N**ational Futures Association ("NFA") created a set of bullet points as a starting point to develop your Cyber Security Procedure. <u>You should carefully</u> <u>consider your firm's operations before deciding</u> that a particular point is not applicable.

1.) Identification of threats & vulnerabilities:

- A.) Taking an inventory of information & assets
- B.) Conducting a risk assessment

2.) Deployment of protective measures against the identified threats & vulnerabilities:

- A.) Physical security
- B.) Technical security
- C.) System & information integrity
- D.) Data movement
- E.) Maintenance
- F.) System activity monitoring & audit records
- G.) Personnel
- H.) Security training
- 3.) Detection of threats in a timely manner
- 4.) Response to events that threaten the security of electronic systems
- 5.) Recovery from threatening events
- 6.) Training
- 7.) Annual review of ISSP

#### **Customer Account Documents**

As you may be aware, RJO recently took the time to revamp the Customer Account Agreement. The updated account agreement has a revision date of 1/16 and is available download for website on our at. https://www.rjobrien.com/account/forms. Additionally, printed booklets are now available upon request. Please contact Customer Accounts at customeraccounts@rjobrien.com with questions or booklet requests. Effective May 1, 2016, RJO will no longer accept Account Agreements with a revision date earlier than 1/16. You are required to send all the pages from the account application booklet, not just the signature pages. If you only send signatures pages, it will delay the opening of the account.

RJO has also updated the W-9 in our account booklets to the current IRS W-9. This updated form is on our website under "additional documents". If you are using the paper copies of the account booklet, make sure that you download the correct W-9 for your customer to fill out. The new W-9 is required for any new U.S. Customer account to be opened.

The Preliminary Risk Assessment form has been updated as well. Please use this new version when you are turning in any new customer account documents.

#### ACH Authorization

Due to ongoing AML regulations, RJO is required to verify the origination of funds on all electronic fund transfers, including ACH transfers. Effective <u>June 15, 2016</u>, an image of a voided check that matches the bank account referenced must accompany each completed ACH Authorization Agreement submitted to RJO for setup. Please make sure the name of the bank account, bank account number, and routing number are all clear and visible for verification.
